A Biography of the Butler Legacy

It all began with Louis Alexander (1930 – 1977) and Blanche Veronica (1931 – 2008) who were joined in Holy Matrimony in 1950 and blessed with seven children, Dayrrl Raymond, Derek Anthony who died at age six, Emily Marie, Anthony Joseph, Christine Mary, Jerry Christopher and Louis Alexander Jr. The children all attended St. Francis or Xavier's Schools and St. Augustine's College. The Butlers were devout Catholics living in a home where love, sharing, manners, hard work, ambition, humility and success were instilled. The Butler family established permanent roots in Joan's Heights in 1967. From this homestead, Dayrrl (Dale) completed his final year at the all-boys campus, top of the hill at SAC and joined the first group of co-ed Form V graduating in 1968. In September 1967, Emily joined the class of FIRSTS – first group of common entrants to grace the brand new lower-level classrooms wearing the new uniform; first co-ed Form I to enter and graduate SAC; and the largest class to graduate SAC in 1972! Anthony (Tony) joined SAC in 1972 and was the last of the children to complete Forms I - V versus Grades 6 - 12. Both Christine in 1974 and Jerry in 1975 followed. Christine graduated in 1980 and Jerry in 1981. Finally, in 1979, Louis (Junior) followed his siblings and graduated in 1985. To his credit, he was the most outstanding senior athlete in Track & Field that year.

Dayrrl, **CA**, started the college ball rolling in 1968! In his four years at St. John's University, MN., he earned a double major and a minor (Acct. & Econ.; Comp. Science), went on to work at Coopers & Lybrand in NYC and Thorne Riddell in Toronto before returning home to become one of the youngest Bahamian Partners, a first for SAC. Later he, along with Partner Mike Taylor, established Butler & Taylor which he still runs today. He also owns and operates ABC Restaurant & Bar and Brother B's along with wife, Marva.
